## **Biographies of Panelists:**

**Catherine R. Kinney**, 52, has been president and co-chief operating officer of the New York Stock Exchange since January 2002.

Prior to her current position, Mrs. Kinney was group executive vice president since June 1995, overseeing the Exchange's competitive position and relationships with its listed companies, member firms and institutions as well as the Exchange Traded Funds, and Fixed Income divisions. Prior to that, since 1986, she was responsible for managing trading-floor operations and technology. Joining the NYSE in 1974, Mrs.

Kinney has worked in several departments, including regulation, sales and marketing, and technology planning.

Mrs. Kinney is a member of the board of the New York Stock Exchange Foundation, the Depository Trust & Clearing Corporation (DTCC), the Board of Regents at Georgetown University and the Board of Junior Achievement of New York. She served on the Board of the Metropolitan Life Insurance Co. from 2002-2004.

Mrs. Kinney graduated Magna Cum Laude from Iona College and completed the Advanced Management Program, Harvard Graduate School of Business. She has received honorary degrees from Georgetown University and Rosemont College.

**Amy S. Butte** was appointed New York Stock Exchange executive vice president, Corporate Finance, on Feb. 6, 2004 and on April 12 was named chief financial officer. Ms. Butte, 37, is responsible for the financial operations of the NYSE including the Controller's Department, Treasurer's Department, and Financial Planning and Analysis. She oversees the annual operating and capital budgets, the Exchange's performance against those budgets, and coordinates the NYSE's revenue structure.

Prior to joining the Exchange, Ms. Butte most recently was chief strategist and chief financial officer with Credit Suisse First Boston's financial-services division. Prior to that, she had been a senior managing director in Equity Research at Bear Stearns & Co., Inc.

Ms. Butte began her equity research career at Merrill Lynch. She also worked at Bridge Trading Co., Inc.; Merrin Financial; and Anderson Consulting.

Ms. Butte has a bachelor's in Political Science and Psychology from Yale University and an MBA from Harvard University Graduate School of Business Administration. She serves on the Corporate Advisory Board of the New York City Ballet, and is an active member with the New York Women's Foundation.

**Matt Andresen** is President of Citadel Execution Services, a division of Citadel Investment Group. Citadel is one of the world's largest Hedge Funds, with over \$11 Billion under management. Mr. Andresen also served on the Board of Directors of Lava Trading, a New York based trading technology company, until its recent sale to Citigroup.

Prior to joining Citadel, Mr. Andresen was President and CEO of Island ECN, the largest electronic stock market in the US. As one of the first three employees, he was responsible for all strategic and operational decisions at Island. Under his leadership, Island achieved numerous successes:

- -Executing 25% of Nasdaq trades
- -600 Million shares of daily trading volume
- -Largest marketplace for ETFs

In June of 2002, he affected the sale of Island to its largest competitor, Instinet (Nasdaq: INET) in a transaction valued at \$568 Million. After the merger, Mr. Andresen assumed the duties of Chief Operation Officer for the combined ECN.

Mr. Andresen has appeared as an expert before many Congressional Committees, on subjects as diverse as Venture Capital in Biotechnology, the future of Electronic Markets, the impact of technology on Commodity markets, and the effect of September 11 on Financial Markets. He is a regular commentator on various financial and news outlets.

Mr. Andresen was named as one of the Top Ten executives in Online Finance by Institutional Investor. Crain's Magazine named him one of the Top 40 New Yorkers under the age of 40. Mr. Andresen holds a B.A. in Economics and Political Science from Duke University in Durham, NC. A former world-class Fencer, Mr. Andresen was a National Champion, a four-time All-America, a member of the US National Fencing Team, and an alternate for the 1996 US Olympic Team.
