**Dinakar Singh Speaks on the Opportunities and Challenges Ahead

**Biography:**

Dinakar Singh is the founding partner of TPG- Axon Capital, a leading global investment firm. Through offices in New York, Hong Kong, and Tokyo, TPG-Axon invests over \$5.5 billion of investor capital in public and private markets across the world. The firm was founded by Mr. Singh in late 2004, in partnership with Texas Pacific Group, a leading private equity firm. TPG-Axon currently has approximately 70 people analyzing investments in over 20 different countries, and spanning an investment spectrum ranging from public equities to structured private investments.

Mr. Singh was previously a partner at Goldman Sachs, where he was co-head of the Principal Strategies department. The Department is one of the key franchises at the firm, and is responsible for investing the firm's capital across global markets. Mr. Singh helped build and lead a premier global multi-strategy investment group, and had responsibility for a multi-billion dollar portfolio of investments spanning a wide spectrum of products and markets. In addition, during his 14 years at Goldman Sachs, he served on a number of the firm's key leadership committees, including the Securities Division Operating Committee, Risk Committee, Partnership Committee, and Asia Management Committee. While at Goldman Sachs, he spent four years based in Hong Kong, establishing the Principal Strategies efforts across Asia, and building teams in Hong Kong and Japan.

He is a founder and Chairman of the Spinal Muscular Atrophy Foundation, and also serves on the Columbia University Medical Center Board of Visitors. In addition, he is a member of the Trilateral Commission, and serves on the Yale University President's Council on International Activities.
