She also led the AlixPartners team advising ANC Rental Corporation, parent company of National and Alamo car rental companies, focusing on operational consolidations and cost reductions, and served as interim CFO at United Companies Financial Corporation from October 1999 until November 2000, the effective date of the plan. She built cash reserves which allowed the company to pursue an operating strategy which, coupled with an astutely managed auction process, resulted in maximized asset sales proceeds for the benefit of United's creditors.

Prior to joining AlixPartners, Becky was a director in the corporate finance, regeneration and disputes practice for PricewaterhouseCoopers. Previously, she provided litigation support, fraud investigative work, and corporate recovery consulting services for Ernst & Young LLP.
