## Biography

Gay Huey-Evans, Tribeca Global Management (Europe) Ltd

Ms Huey Evans, President of Tribeca Global Management (Europe) Ltd joined Tribeca Global in September 2005. Prior to joining Tribeca, she had been the Director of Markets at the Financial Services Authority (1998-2005) responsible for the UK Listing Authority, supervision of all market infrastructure providers (exchanges, clearing and settlement houses), market policy and market surveillance (including the Code of Market Conduct). She was appointed Capital Markets Sector Leader at the FSA. Prior to her joining the FSA, Ms. Huey Evans worked with Bankers Trust Company (1984-1998) in both New York and London as a Senior Managing Director in the Capital Markets in a variety of positions.

In February 2006 Ms Huey Evans was appointed to the European Commission's Expert Group on Alternative Investment Funds.

In 2004, Ms Huey Evans was appointed chairman of the Joint Forum, a group of experts working under the umbrella of the Basel Committee on Banking Supervision (BCBS), the International Organization of Securities Commissions (IOSCO) and the International Association of Insurance Supervisors (IAIS). While at Bankers Trust, she was the Chairman of the International Swaps and Derivatives Association (ISDA) from 1994-1998. In 2007, she became a member of Risk Who's Who and was honoured by 100 Women in Hedge Funds with the European Leadership Award. She holds a BA in Economics from Bucknell University.

Ms Huey Evans is a co-opted member of Tate's Audit and Finance and Operating Committees, and a Trustee of Wigmore Hall. Ms Huey Evans is also Advisory Committee member of Cambridge Finance, Centre for Financial Analysis and Policy, a manager of Cambridge Endowment for Research in Finance (CERF), and a member of the President's Advisory Council of Barnard College in New York.
