Peter R. Fisher, Managing Director, is co-head of BlackRock's Fixed Income Portfolio Management Group. He is a

member of the Executive Committee, and he co-chairs the Fixed Income Investment Strategy Group that is responsible for global fixed income strategy, asset allocation and overall management of client portfolios.

In 2005, Mr. Fisher was named Chairman of BlackRock Asia and was responsible for the firm's businesses in Japan, Korea, the People's Republic of China, Hong Kong, Taiwan, Singapore, and Southeast Asia. Prior to joining BlackRock in 2004, Mr. Fisher served as the Under Secretary of the U.S. Treasury for Domestic Finance from August 2001 to October 2003 and, in that capacity, also served as the Treasury Board representative to the Pension Benefit Guaranty Corporation (PBGC) and as a member of the Board of the Securities Investor Protection Corporation (SIPC).

Before joining the Treasury, Mr. Fisher spent 15 years at the Federal Reserve Bank of New York, concluding his service there as Executive Vice President and Manager of the System Open Market Account. Mr. Fisher is a non-executive Director of the Financial Services Authority of the United Kingdom and also serves on the Board of the Episcopal Church Foundation. Mr. Fisher earned a BA degree in history from Harvard College in 1980 and a JD degree from Harvard Law School in 1985.
