Biographies

Jane Mendillo, President & CEO, Harvard Management Company

Jane Mendillo joined Harvard Management Company (HMC) as President and CEO, effective July 1, 2008. As CEO, she is responsible for the investment policy and management of Harvard University's \$40 billion endowment portfolio. Prior to joining HMC in July 2008, Ms. Mendillo served as the Chief Investment Officer of Wellesley College since February 2002. There she built the college's first investment office, directed the restructuring of its investment portfolio, and achieved substantial and sustained endowment growth through a period of rapidly changing market conditions.

Prior to Wellesley, Ms. Mendillo served as one of Harvard Management Company's senior investment officers. In nearly 15 years at Harvard Management Company, from 1987 until early 2002, Ms. Mendillo held a series of positions, ultimately as Vice President of External Management. In that role, to which she was appointed in 1997, she was responsible for directing the investment of a portfolio that grew to \$7 billion in assets, including \$6 billion in externally managed endowment assets (including investments in private equity, real estate, emerging markets, and natural resources, among other areas) and \$1 billion in pension and related accounts.

Previously, as Vice President for Trusts (1992-96), Vice President for Private Equity (1989-91), and a member of the Internal Equities management team (1987-89), Ms. Mendillo made and managed investments for Harvard in a variety of US and International markets including the University's first holdings in timberland.

Ms. Mendillo received the 2007 Industry Leadership Award given by 100 Women in Hedge Funds, in recognition of her "talent, ethics, and passion, which help define the hedge fund industry's standard of excellence."

Ms. Mendillo received her B.A. and M.B.A. degrees from Yale University. Early in her career, she was a management consultant with Bain & Company in Boston. She is a Chartered Financial Analyst and a member of the Boston Security Analysts Society, Inc., the Boston Committee on Foreign Relations, and the Boston Economic Club.

Dana Fisk Pitts, Managing Director, JP Morgan & Co.

Dana Fisk Pitts is a Managing Director of JP Morgan Chase Commercial Bank where she manages the Commercial Bank Funds Group. She has joined JP Morgan Chase in Hong Kong in 1982, the last five years holding her current position. Her career has focused on the alternative asset industry since 1988. She has held various positions in Investment Banking Coverage, Sales & Trading, and Corporate Finance. Ms. Pitts has lived and worked in New York (JP Morgan Chase), Hong Kong (Chemical Bank), Istanbul and Paris (Citibank).

She received her B.A., from Wellesley College, a Museology degree from Ecole du Louvre, and attended Smith College management program and Chase Executive Development program. Ms. Pitts is a member of the New York Financial Women's Association and active since inception with 100 Women in Hedge Funds and Hedge Funds Care. She received the Hedge Funds Care Award for Caring on January 10, 2008.

Paige C. Scott is a partner with Sextant Search Partners' Traditional Asset Management and Hedge Fund Practices. Based in Boston and San Francisco, Paige focuses on senior-level searches for institutional sales and marketing, institutional client service, and consultant relations professionals; equity and fixed income portfolio managers and product specialists; equity and fixed income analysts; chief investment officers; hedge fund investment professionals; heads of wealth management and investment portfolio managers.

Previously, Paige was a senior recruiter for Source Finance in San Francisco, where she was instrumental in building the firm's West Coast practice. She began her career working on due diligence and trial preparation for the law firm for Furth, Fahrner & Mason.

FROM THE NORTH

FOLLOW I-93 SOUTH TO EXIT 23 - PURCHASE STREET. STAY RIGHT OFF THE EXIT ONTO PURCHASE STREET. FOLLOW PURCHASE STREET 2 BLOCKS AND TURN LEFT ONTO CONGRESS STREET. TAKE AN IMMEDIATE LEFT ONTO ATLANTIC AVENUE. FOLLOW ATLANTIC AVENUE 3 BLOCKS AND THE HOTEL WILL BE ON YOUR RIGHT. PULL INTO OUR DRIVE THROUGH FOR VALET PARKING. CONTINUE PAST THE HOTEL ENTRANCE TO THE PARKING ENTRANCE FOR SELF PARKING.

FROM THE SOUTH

TAKE RTE I-93 NORTH TO EXIT 20 FOR SOUTH STATION. FOLLOW SIGNS TO SOUTH STATION/DOWNTOWN. TURN RIGHT AT THE END OF THE RAMP ONTO KNEELAND STREET AND TURN AT THE SECOND LEFT ONTO ATLANTIC AVENUE. CONTINUE STRAIGHT ON ATLANTIC AVENUE. TURN RIGHT WHERE YOU WILL SEE A SIGN FOR THE BOSTON HARBOR HOTEL. THE VALET AND FRONT DOOR OF THE HOTEL WILL BE IMMEDIATELY IN FRONT OF YOU. FOR SELF PARKING, CONTINUE PAST THE ARCH IN THE BUILDING AND MAKE A RIGHT TURN FOR THE GARAGE ENTRANCE.

FROM THE WEST

FOLLOW THE MASSACHUSETTS TURNPIKE/RTE I-90E TO EXIT 24A FOR SOUTH STATION. THIS WILL PUT YOU ONTO ATLANTIC AVE. THEN FOLLOW ATLANTIC AVENUE (WHICH IS ONE-WAY). TURN RIGHT WHERE YOU WILL SEE A SIGN FOR THE BOSTON HARBOR HOTEL. THE VALET AND FRONT DOOR OF THE HOTEL WILL BE IMMEDIATELY IN FRONT OF YOU. FOR SELF PARKING, CONTINUE PAST THE ARCH IN THE BUILDING AND MAKE A RIGHT TURN FOR THE GARAGE ENTRANCE.

FROM NORTHWESTERN SUBURBS AND RTE 2

FOLLOW SIGNS FOR RTES. 2 & 3 TO MEMORIAL DRIVE ALONG THE CAMBRIDGE SIDE OF THE CHARLES RIVER (BY THE MOUNT AUBURN HOSPITAL THE RIVER ON YOUR RIGHT). CONTINUE ON MEMORIAL DRIVE AND TURN RIGHT AT THE FIRST LIGHT (BY HARVARD'S KENNEDY SCHOOL OF GOVERNMENT) TO CROSS THE RIVER AND THEN TURN LEFT ONTO STORROW DRIVE HEADING EAST ALONG THE BOSTON SIDE OF THE RIVER (RIVER ON YOUR LEFT). FOLLOW STORROW DRIVE TO THE END AND GET ONTO RTE. I-93 SOUTH. TAKE EXIT 23 FOR PURCHASE STREET. GO STRAIGHT AHEAD AND TURN LEFT ONTO CONGRESS STREET. TURN LEFT AGAIN IMMEDIATELY ONTO ATLANTIC AVENUE. CONTINUE STRAIGHT ON ATLANTIC AVENUE. TURN RIGHT WHERE YOU WILL SEE A SIGN FOR THE BOSTON HARBOR HOTEL. THE VALET AND FRONT DOOR OF THE HOTEL WILL BE IMMEDIATELY IN FRONT OF YOU. FOR SELF PARKING, CONTINUE PAST THE ARCH IN THE BUILDING AND MAKE A RIGHT TURN FOR THE GARAGE ENTRANCE.

FROM LOGAN AIRPORT (Rte. 1A)

FOLLOW SIGNS IN THE AIRPORT TO THE TED WILLIAMS TUNNEL / RTE. I-90 WEST TO EXIT 25 FOR SOUTH BOSTON. AT THE SECOND TRAFFIC LIGHT, TURN LEFT ONTO SEAPORT BOULEVARD. FOLLOW SEAPORT BOULEVARD STRAIGHT AHEAD AND OVER THE MOAKLEY BRIDGE. AFTER CROSSING THE BRIDGE, TURN RIGHT FOLLOWING THE SIGNS FOR ATLANTIC AVENUE. TURN RIGHT WHERE YOU WILL SEE A SIGN FOR THE BOSTON HARBOR HOTEL. THE VALET AND FRONT DOOR OF THE HOTEL WILL BE IMMEDIATELY IN FRONT OF YOU. FOR SELF PARKING, CONTINUE PAST THE ARCH IN THE BUILDING AND MAKE A RIGHT TURN FOR THE GARAGE ENTRANCE
