Biographies

Elizabeth Wilner, Director of Public Affairs, Peter G. Peterson Foundation

Elizabeth communicates the Foundation's message and persuades her former colleagues in the news media to cover the future, not just the present. Prior to joining the Foundation, Elizabeth spent 15 years covering and analyzing American politics for some of the nation's most sophisticated news organizations. As Political Director of NBC News, she organized the network's campaign coverage, creating a centralized unit to serve all of NBC's platforms and supervising NBC's 2004 "embed" team. She was a chief editorial voice in planning coverage of major campaign events from the lowa caucuses through the presidential conventions to Election Night. She also oversaw the network's polling partnership with The Wall Street Journal and founded MSNBC.com's popular political blog First Read. NBC News created the Political Director job for her when she came on board in 2003.

Before arriving at NBC, Elizabeth spent five years as Deputy Political Director of ABC News, where she co-founded the ground-breaking online news digest The Note. She began her career in political journalism at The Cook Political Report, the respected nonpartisan newsletter. Her op-eds and columns have appeared in national publications including The Washington Post, USA Today, and The Politico, and she also advises on the organization of presidential candidate forums and debates. Elizabeth has toured Europe as an American Marshall Memorial Fellow, a program of the German Marshall Fund of the United States, and has degrees from Trinity College in Connecticut and the Medill School of Journalism at Northwestern University. She lives in New York.

Susan Tanaka, Director of Citizen Engagement and Education, Peter G. Peterson Foundation Susan is a professional budget analyst. Not only does she try to understand policies and the numbers that make up the federal budget, but she also tries to translate them for non-budgeteers. Susan has worked on the federal budget from both ends of Washington's Pennsylvania Avenue, first spending nine years as a member of the career staff of the Office of Management and Budget. She held dual roles at the Congressional Budget Office as a senior analyst in budget projections and Associate Director for Communications. In between those government positions, she was the Vice President of the bi-partisan Committee for a Responsible Federal Budget and directed its Health Care Reform Project. While there, she developed materials to raise the level of awareness among policy makers, the media and the public about the fiscal challenges facing the nation and to find ways to engage citizens in discussions about solutions.

As the Foundation's Director of Citizen Education and Engagement, Susan's focus is on in-house and grantee-led projects to educate the public about the nation's serious fiscal challenges and to encourage citizens to become engaged in finding solution to those problems. She has consulted for non-governmental organizations including the Organization for Economic Development and Cooperation, the National Academy for Public Administration, and The Concord Coalition. She holds an M.B.A. from the Yale School of Management, an M.A. from the Fletcher School of Law and Diplomacy, and a B.A. from Antioch College. She resides in New York.
