This now has two components - a listed fund management company - Charlemagne

Capital - and an Asian mining group, Regent Pacific. In addition, Jim is the controlling shareholder and a director of Manx Financial Corporation , an Isle of Man based bank, Speymill Group, a property business, and Webis Holdings. He is a co-founder of Uramin and Red Dragon Resources, both mining groups. Burnbrae, his private company, is a substantial landlord in Germany and in the Isle of Man, and also owns outright the hotel chain Sleepwell Hotels. Jim spends most of his time working on startup ideas and on investing. His book, 'Wake Up!' was published in 2005 and the second book "10 Investments for the Ten Years Ahead " in 2008 and the latest book was published in 2009 called" Top Ten Investments to Beat the Crunch" . Jim lives in the Isle of Man, Brussels and Ibiza.
