Jack Meyer, Senior Managing Partner, Convexity Capital Management

Jack R. Meyer is Senior Managing Partner at Convexity Capital Management L.P. located in Boston. He co-founded the firm with managing partners, Dave Mittelman and Maurice Samuels in July 2005. Before Convexity,

Jack was President and CEO of Harvard Management Company, which manages the University's endowment assets, pension funds, charitable trusts and pooled income funds totaling in excess of \$31 billion by the end of his term.

Prior to HMC, Jack was Treasurer and Chief Investment Officer of the Rockefeller Foundation where he managed the Foundation's endowment, valued at \$2 billion. Before the Foundation, he was Deputy Controller of New York City, where he managed \$20 billion in total assets, including the City's pension funds, sinking funds, and treasury funds. He also held various investment management positions with Lionel D. Edie, a New York City investment firm and at Brown Brothers Harriman & Co.,

Jack currently serves as the Chair of the Asian University for Women Support Foundation, and the Chair of the Boston Ballet. He also is on the Board of Directors of The Boston Foundation. Previously, he served as a Director of the Investment Responsibility Research Council, and on the investment committees of the Howard Hughes Medical Institute, the Massachusetts State Pension Fund, and the Atlantic Foundation.

He received a Bachelor of Science degree from Denison University. In 2004 Denison awarded him an honorary doctorate degree. He received his Masters in Business Administration from Harvard Business School. He is married, has two children and lives in Cambridge, Massachusetts.

Ms. Kelleher began her career at Harvard Management Company in 1996 in the Risk Management Department. Her responsibilities included negotiation of contracts for international and domestic investment relationships. Ms. Kelleher was responsible for legal and business risk analysis of investment instruments for portfolio managers and assisted with the establishment of risk and regulatory compliance standards and procedures. In 1999, Ms. Kelleher began an investment role in Harvard's commodities portfolio where she analyzed, valued, and negotiated private equity and structured finance transactions. Concurrently, she participated in international equity portfolios with legal, regulatory and strategy issues surrounding proposed restructurings of closed-end funds and share class trades. Ms. Kelleher left HMC in July 2004 to become a Founding Partner of Sowood Capital Management LP. At Sowood, she was responsible for all non-investment aspects of the business and, in addition, maintained her involvement in investments requiring legal and/or negotiation expertise. Ms. Kelleher joined UBS Investment Bank in June 2010 as Managing Director for Prime Brokerage in the New England region.
