Emily Porter, Portfolio Manager, USS

Previously, Emily was employed by Key Asset Management as a Portfolio Manager and Investment Director where she concentrated on Event Driven and Distressed hedge fund research, as well as managing Multi Strategy Fund of Hedge Fund portfolios. Prior to joining Key Asset Management, Emily worked for Asset Alliance as a European and Asian focused generalist hedge fund senior analyst, Aurum in hedge fund analysis and ABN AMRO Asset Management as a hedge fund analyst. Emily received an LLB in Law from Southampton University and is a holder of the Chartered Alternative Investment Analyst (CAIA) designation.

Lisa Fridman, Head of European Research, PAAMCO

Lisa Fridman, CFA, CQF, is the Head of European Research at Pacific Alternative Asset Management Company, LLC ("PAAMCO"), a fund of hedge funds with \$10 billion in discretionary assets. In this role, she is involved in sourcing, due diligence and monitoring of the firm's European hedge fund investments with a particular focus on risk management. Lisa is a voting member of Risk Management and Strategy Allocation Committees at PAAMCO. Additionally, Ms. Fridman is responsible for portfolio construction and account management for several of the company's largest clients. She also runs the UK Investment Analyst program for PAAMCO. Ms. Fridman graduated from University of California, Los Angeles with a BA in Business Economics and received an MBA in Finance from UCLA Anderson School of Management.

Victoria Makepeace-Warne, Portfolio Manager, Pamplona Capital Management

Victoria Makepeace-Warne is a portfolio manager at Pamplona Capital Management and is responsible for Equity and Event Driven Strategies on the fund of hedge funds team. Previously she was a senior analyst and portfolio manager on the fund of hedge funds team at Schroder Investment Management. She also held positions as senior investment analyst responsible for alternative investments at Abbey National Treasury Services and research analyst at Atlas Capital Ltd.

Kathryn Graham, Director, BT Pension Scheme Management Limited

Ms. Graham is a Director of BT Pension Scheme Management Limited (BTPSM), the pension's advisory arm of the BT Pension Scheme, the largest in the UK. She joined BTPSM in 2004 to help establish a new team mandated to invest up to 5% of the BT Scheme directly into single hedge funds. In 2007, she took responsibility for Manager Selection across the BT Scheme before setting up a new team tasked with Liability Management. She has more than 15 years experience in capital markets, derivatives, and hedge funds both as an end buyer and a structurer. She began her career at SJ Warburg in 1994 in fixed income derivatives and also worked at UBS and Progressive Alternative Investments before joining BTPSM. She was educated at Edinburgh University, where she was awarded an MA in Economics and Mathematics. Ms. Graham is a member of the BTPSM Investment Committee, through which she is involved in all aspects of the scheme's investments. She is a member of the London Board of 100 Women in Hedge Funds, is a founding trustee of the Hedge Funds Standards Board and was included on the FN100 list of Influential Women in European Financial Markets and the HFM Week list of the 50 most influential people in hedge funds.
