Morgan Sze, Founder, Azentus Capital Management Limited

Morgan Sze is the Chief Investment Officer of Azentus Capital Management Limited, an Asian-research driven global investment fund. Morgan was previously at Goldman Sachs for 17 years, most recently as Global Head of Goldman Sachs Principal Strategies, and a member of the Firmwide Risk Committee and Asia Securities Division Operating Committee. He joined Goldman Sachs in 1993 in Investment Banking in New York. In 1996, he co-founded the Risk Markets Group, which helped to develop the market for earthquake and hurricane bonds, and in 1998 he moved to London to start Risk Markets in Europe. In 2001, he joined International Equity Arbitrage in London and in 2006 moved to Hong Kong. Morgan worked at Merrill Lynch from 1988 to 1991 in New York and Tokyo.

Morgan earned an MBA from the University of Chicago in 1993 and a BA from Cornell University in 1987.
