At BMO, Mr. Wise was appointed the youngest Managing Director in the firm's history. Prior to his role at BMO, Mr. Wise was a vice president at Citigroup where he managed the Canadian equity derivatives trading business from 1998 to 2001. His team specialized in equity and index derivatives trading, volatility arbitrage and corporate derivatives structuring.

Mr. Wise has an undergraduate business degree (hons.), graduating first in his class from the Ivey School of Business at the University of Western Ontario in 1998. Mr. Wise holds the CFA designation and has completed multiple regulatory examinations in Canada and the United States.
