



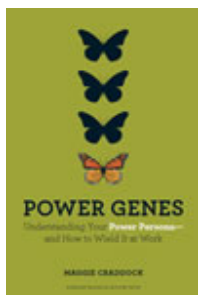
**Education Session No. 288:
