#### Eléonore de Villepin-Louvard, Head of Project Finance, CNIM

Eléonore de Villepin-Louvard is Head of Project Finance and Structured Finance at CNIM, a French engineering and industrial company operating two divisions: Energy & Environment (contractor and operator of Waste-to-Energy plants, biomass plants and concentrated solar plants) and Defence & Systems (military equipment). She is responsible in originating, structuring and closing PPP transactions in Europe / Eastern Europe and Middle East. Mrs de Villepin is currently Board Director of three UK companies in the waste-to-energy sector.

Formerly Mrs de Villepin worked 7 years in the US at Lehman Brothers New York as a Senior Associate in the Leveraged Finance and as a Vice President in Structured Finance. She has a BA from the French Business School EM Lyon with concentration in finance.

#### Miniya Chatterji, Founder, The Stargazers Foundation

Miniya works at an international organization in Geneva, over seeing the Middle East, North Africa and South Asia regions.

She is the founder of The Stargazers Foundation, a not for profit organization that encourages the youth to think afresh, have the courage to come forth with new ideas, be creative, innovate, and... stargaze. Via partnerships, mentoring programs, business incubators, Stargazers engages with visionaries, leaders and companies to together build a community that nurtures young talent, encourages innovation, and in this way finds fresh perspectives to old ways of doing business. Miniya is also a writer - she often writes opinion pieces and political essays in newspapers. As evident she feels strongly for social issues and justice in general (and therefore participated in revolutions in the Middle East while living there), has taught at universities, dabbled at a start up, and worked for a few good years in politics in France where she worked closely with the office of President Jacques Chirac at the Elysee.

Before moving on to do her bit towards the 'real' issues faced by the world, Miniya was making investments in hedge funds as analyst and co-managing 2 Funds of Hedge Funds of \$200 million assets under management in Paris, and before that was managing wealth for the ultra rich at Goldman Sachs in London.

#### Mairi Eastwood, Partner, Praesta Partners LLP

Mairi Eastwood is co-founder and partner of Praesta Partners LLP, a leading executive coaching firm in the UK, with an associated firm, Praesta France, based in Paris and offices in eleven other countries. Mairi has Master Coach accreditation and works with senior leaders of both genders around Board level in the financial, professional, commercial and public sectors. In the UK, the partners of Praesta together coach about 450 senior executives each year, of whom about 120 are women.

Prior to becoming a coach, eleven years ago, Mairi ran a boutique consulting firm and prior to that she was one of the first women partners in Ernst &Young UK, where she sat on the management committee. Mairi has also sat on a number of not for profit and private company boards in a non-executive capacity. She has two grown up children

Alain Pronost joined Global Graphics as Chief Financial Officer in August 1999 and was appointed a director of the Company in June 2000, where he also fulfils the company secretary and compliance officer roles.
