In 2001 Mr. Lohmann managed the spin-off of ZFS' assumed reinsurance business into Converium which was sold to the public through an IPO in December 2001. Mr. Lohmann served as Chief Executive Officer of Converium until February 2005.

Prior to establishing Secquaero Advisors Ltd. in February 2007, he established an independent consultancy, Lohmann Convergence Capital Advisory, providing hedge funds, intermediaries and reinsurance companies with advice on the strategic application of insurance securitisation and investing in insurance linked securities.

Dirk Lohmann has a Bachelor of Arts in Economics from the College of Literature, Science and Arts at the University of Michigan, a MBA from the Rotman School of Business at the University of Toronto and an Executive MBA from the University of St. Gallen.
