Eileen Murray rose from the ranks as an analyst at Morgan Stanley to become a Managing Director and then Controller and Treasurer. She later served on Morgan Stanley's Management Committee. At Credit Suisse, she was the first woman to serve on CSFB's Executive Board. Murray now serves as Co-CEO of the largest hedge fund in the US.

Eileen Murray, Co-CEO, Bridgewater Associates

Eileen Murray is Co-CEO and member of the Management Committee at Bridgewater Associates, LP. Ms. Murray has over two decades of Wall Street experience, having held senior leadership roles at Morgan Stanley and Credit Suisse as a member of both firm's Management Committee, Executive Committee. She was also appointed the first female member of Credit Suisse's Executive Board.

Ms. Murray joined Morgan Stanley in 1984 and held the positions of Controller, Treasurer as well as Chief Operating Officer for the Institutional Securities Group. In 2002 Ms. Murray joined Credit Suisse as a Management and Executive Board member and Head of Global Technology, Operations and Product Control. She returned to Morgan Stanley in 2005 as an Executive and Management Committee member, as well as Head of Global Technology and Operations.

Prior to joining Bridgewater in 2009, she had most recently served as President and Management Committee member of Duff Capital Advisors.

Ms. Murray is currently a member of the Board of Trustees of Manhattan College (where she earned a B.S. in Accounting), the YMCA of Greater New York and Inwood House. She has served on the Board of Governors of Argonne National Laboratory at the University of Chicago, the Hewlett Packard Financial Services Board of Advisors, OMGEO Board, Depository Trust and Clearing Corporation Board (DTCC) and the American Women's Economic Development (AWED) Corporation.

In recognition of her leadership in the financial services industry, Ms. Murray has received the Women's Bond Club Merit Achievement Award, Legal Momentum's Aiming High Award, and the Urban Stages Humanitarian Award. U.S. Banker named her as one of the 20 Most Powerful Non-Bank Women in Banking in 2008.

Richard Lui, Journalist and Anchor, MSNBC

Richard Lui is an American journalist and dayside news anchor for MSNBC. Lui is also a rotating news anchor for NBC's weekend Today show and contributes reports for NBC News Investigations Unit and NBC Weekend Nightly News. He's based at NBC's offices at 30 Rockefeller Center.

Before joining MSNBC, Lui was a news anchor for five years at CNN Worldwide, desking shows on CNN International, CNN U.S., and CNN Headline News. He solo-anchored the 10am edition of Morning Express and led morning political reporting during the 2008 Presidential election as a member of Morning Express with Robin Meade. When Lui joined CNN Headline News in 2007 he became the first Asian American male to anchor a daily, national cable news show in the U.S. Mediaite ranks Lui #102 in News Buzz on its Power Grid Influence Index of TV Anchors / Hosts.

Before journalism, Lui spent 15 years in business with Fortune 500 and technology companies. This included work at Oliver Wyman, and patenting and launching the first bank-centric payment system in a Citibank carve-out he founded with fellow University of Michigan MBA alumni.

Lui has been active in community leadership for 25 years in Africa, Asia, and the U.S. He leads pro bono strategy consulting teams and is a board member for non-profits in homeless and affordable housing. Lui speaks frequently, including events for the U.S. State Department, Harvard, and the Aspen Institute.

A first generation American, Lui has a twist in his background - Wong is his real last name, part of an immigration wrinkle because his grandfather, an illegal immigrant, filed false "Paper Sons" papers.

Lui graduated from UC Berkeley, earned an MBA from the Ross School of Business at the University of Michigan, and is currently enrolled at Stanford University in its postgraduate program on International Security.

Lui has worked, lived, and studied in Europe, Asia, and the U.S, where he currently resides.
