Biographies

Janet M. Currie, Henry Putnam Professor of Economics and Public Affairs, Princeton University

Janet Currie is the Henry Putnam Professor of Economics and Public Affairs at Princeton University and the Director of Princeton's Center for Health and Well Being. She also directs the Program on Families and Children at the National Bureau of Economic Research. She has served on several National Academy of Sciences panels including the Committee on Population, and was elected Vice President of the American Economics Association in 2010. She has also served as a consultant for the National Health Interview Survey and the National Longitudinal Surveys and on the advisory board of the National Children's Study. She is a Fellow of the Society of Labor Economists, an affiliate of the University of Michigan's National Poverty Center, and an affiliate of IZA in Bonn. She is the Editor of the *Journal of Economic Literature* and on the editorial board of the *Quarterly Journal of Economics*, and has also served several other journals in an editorial capacity including the *Journal of Health Economics*, the *Journal of Labor Economics*, and the *Journal of Public Economics*.

Her research focuses on the health and well-being of children. She has written about early intervention programs, programs to expand health insurance and improve health care, public housing, and food and nutrition programs. Much of this research is summarized in "The Invisible Safety Net: Protecting the Nation's Poor Children and Families", Princeton University Press. Her current research focuses on socioeconomic differences in child health, and on environmental threats to children's health from sources such as toxic pollutants.

Gary H. Stern, Former President and CEO of the Federal Reserve Bank of Minneapolis and Board Member of the Council for Economic Education

Gary Stern was President and Chief Executive Officer of the Federal Reserve Bank of Minneapolis from March 1985 to September 2009. Mr. Stern, a native of Wisconsin, joined the Federal Reserve Bank of Minneapolis in January 1982 as senior vice president and director of research. Before joining the Minneapolis Fed, Mr. Stern was a partner in a New York-based economic consulting firm. Mr. Stern's prior experience includes seven years at the Federal Reserve Bank of New York.

Mr. Stern serves on the board of directors of FINRA, The Dolan Company, The Depository Trust and Clearing Corporation, Ambac Assurance Corporation and the Council for Economic Education (CEE), where he served for a time as acting President and Chief Executive Officer. Mr. Stern is co-author of [Too Big to Fail: The Hazards of Bank Bailouts](#), published by The Brookings Institution (2004), and is a member of the FDIC's Systemic Risk Advisory Committee.

Mr. Stern holds an A.B. in economics from Washington University, St. Louis, and a Ph.D. in economics from Rice University, Houston. He formerly served as chair of the board of the Northwest Area Foundation, The Minneapolis Club, and the Blue Cross Blue Shield of Minnesota. He was also a board member of the Minneapolis College of Art and Design, Hamline University, and ETS. Stern is the recipient of the 2009 Visionary Award from CEE and the Distinguished Alumnus Award from Washington University's College of Liberal Arts in 2010.
