Joshua Safran is an author, attorney and nationally recognized advocate for survivors of domestic violence. His 7year legal odyssey to free a battered woman from prison was featured in the award-winning documentary *Crime After Crime*, which premiered at the 2011 Sundance Film Festival and on the Oprah Winfrey Network. He has received numerous awards for his advocacy and his essays have been published in Salon and Huffington Post. His memoir, "Free Spirit: Growing Up on the Road and Off the Grid", about his remarkable childhood on the dark side of the Age of Aquarius, was published in 2013 by Hyperion/Hachette.
