Biographies

Edmund Carroll, Managing Director and Global Head of Commodities, UBS Investment Bank

Mr. Carroll began working at UBS in 2003. During this time he has built up and overseen the Commodity Investor business at UBS, including the genesis and development of the market leading index business. 2007 heralded the launch of the UBS Bloomberg CMCI Index, the first second-generation commodity index, holding positions along the forward curve. In 2009, the DJ-UBS commodity index was added to the UBS fold and remains (in its new incarnation as the Bloomberg Commodity Index) one of the most highly tracked and highly regarded commodity benchmarks. Most recently Mr. Carroll completed a landmark deal with Bloomberg to bring both of those index families under a single roof, rebranding the DJ-UBS as the Bloomberg Commodity Index and embarking on a partnership between Bloomberg and UBS for the management and marketing of the index family. Throughout this time UBS has been very active in the structured products space offering to clients structured product and exotic solutions linked to commodity futures as well as a variety of commodity indices and volatility controlled strategies. UBS's Investor Commodities business is one of the biggest such businesses globally offering swaps, notes, options, structured products, exotic options and hybrid derivatives linked to indices and futures. Mr. Carroll is based in New York and oversees the operations of UBS's Commodities businesses globally.

Jennifer Lee, Vice President and Senior Economist, BMO Capital Markets

Jennifer has been with BMO Capital Markets Economics for well over a decade and is perhaps best known in the firm and with clients for her high-frequency data analysis on market-moving U.S. economic releases. Her entertaining, easy-to-understand and call-it-like-it-is writing style has earned her a devoted following. Jennifer is also one of the primary authors of the Department's morning commentary, providing analysis of major economic and political events. As well, she gives regular economic commentary to the global equities sales and trading team following the release of impactful economic data, and monthly presentations on macroeconomic trends to BMO's commercial bankers.
