Biographies

Howard Marks, CFA, CIC, Chairman, Oaktree Capital Management

Since the formation of Oaktree in 1995, Mr. Marks has been responsible for ensuring the firm's adherence to its core investment philosophy; communicating closely with clients concerning products and strategies; and contributing his experience to big-picture decisions relating to investments and corporate direction. From 1985 until 1995, Mr. Marks led the groups at The TCW Group, Inc. that were responsible for investments in distressed debt, high yield bonds, and convertible securities. He was also Chief Investment Officer for Domestic Fixed Income at TCW. Previously, Mr. Marks was with Citicorp Investment Management for 16 years, where from 1978 to 1985 he was Vice President and senior portfolio manager in charge of convertible and high yield securities. Between 1969 and 1978, he was an equity research analyst and, subsequently, Citicorp's Director of Research. Mr. Marks holds a B.S.Ec. degree cum laude from the Wharton School of the University of Pennsylvania with a major in finance and an M.B.A. in accounting and marketing from the Booth School of Business of the University of Chicago, where he received the George Hay Brown Prize. He is a CFA® charterholder and a Chartered Investment Counselor. Mr. Marks is a member of the Investment Committees of the Metropolitan Museum of Art, the Edmund J. Safra Foundation and the Helmsley Charitable Trust; a Trustee of the Metropolitan Museum and Mount Sinai Hospital; and an Emeritus Trustee of the University of Pennsylvania (where from 2000 to 2010 he the chaired Investment Board).

Michele I. Docharty, Goldman Sachs

Michele is co-head of Global Synthetic Products Distribution and Global Head of the Corporate Access and Franchise Services team within the Securities Division. Previously, she was co-head of the Synthetic Products Group in the Americas and served on the Securities Division Counterparty Risk Committee. Michele joined Goldman Sachs in 1989 in the Investment Banking Division and held various positions in sales across the United States and Latin America before assuming responsibility for the Latin American cash business in 1999. She has been consistently active with the firm's diversity efforts, including involvement in the Multicultural Women's Alliance and the Women's Network. Michele was named managing director in 1999 and partner in 2010. Michele earned a BSBA in 1989 from Georgetown University, where she has also been a leader in the firm's recruiting efforts.
