Stephanie Ruhle is an anchor and managing editor for Bloomberg Television and editor-at-large for Bloomberg News, based in New York. She serves as co-host of "Market Makers," airing from 10-12pm ET. She regularly interviews industry titans such as Goldman Sachs CEO Lloyd Blankfein, hedge fund managers David Tepper and Stanley Druckenmiller, NBA star Kobe Bryant, former Vice President Al Gore and music moguls Sean "Diddy" Combs and Kanye West. She founded the Corporate Investment Bank (CIB) Women's Network and co-chaired the Women on Wall Street (WOWS) steering committee. She is also a member of the board of trustees for Girls Inc. NYC and formerly served on the corporate councils of I-Mentor and The White House Project, a non-profit organization working to advance women in business, government and media. She also currently serves on the board and advises for "React To Film," an issue-based documentary film series. Prior to joining Bloomberg, she served as a Managing Director in Global Markets Senior Relationship Management at Deutsche Bank. There, she oversaw relationships for some of Deutsche Bank's largest hedge fund clients.

Sheelah Kolhatkar is a features editor and national correspondent at Bloomberg Businessweek, where she writes features and investigative stories about Wall Street, women in business and national politics, as well as a contributor to Bloomberg Television. She appears as a speaker and commentator on subjects ranging from ethics in the financial industry to the future of hedge funds and gender diversity, and has been interviewed on PBS NewsHour, CBS, NPR and Charlie Rose among others. Prior to becoming a journalist, she was a risk arbitrage analyst at two hedge funds in New York City. She's currently working on her first book, about the government's crackdown on insider trading, to be published by Random House.
