Amanda Pullinger, Chief Executive Officer, 100 Women in Hedge Funds Ms. Pullinger is the Chief Executive Officer of 100 Women in Hedge Funds. She leads a small staff team and manages over 350 volunteer practitioners globally, overseeing the operations of the organization, which now has over 13,000 members in 20 locations.

Ms. Pullinger is a former principal of Aquamarine Capital Management, where she was responsible, over a period of seven years, for managing marketing, investor relations and back office administration for two private investment funds.

Ms. Pullinger is currently on the Boards of two British charities - she is Chairman of the Board of The HALO Trust (<u>www.halotrust.org</u>) and is on the Board of Trustees of SkillForce (<u>www.skillforce.org</u>) and serves on the Advisory Board of the Oxford Alumni Association of NY. She previously served on the Boards of the NYU Cancer Institute and Girls' Prep, and was on the founding Board of 100 Women in Hedge Funds, serving as its President for two years. She is a member of the British Academy of Film and Television Arts (BAFTA) and a Fellow of the Royal Society of Arts.

Ms. Pullinger graduated from Brasenose College, Oxford University in 1987 with an Honours Degree in Modern History. She earned an MBA from La Salle University, Philadelphia, in 1998, and received the Academic Award for MBA student of the year as well as the Beta Gamma Sigma designation.

Emma Reynolds, Co-Founder and CEO, e3Reloaded

Emma Reynolds is an Australian-born entrepreneur, currently living between Hong Kong and Singapore. She left Australia 10 years ago, spending five years in London before moving to Hong Kong in 2010.

She is on a mission, and that mission is disruption. Whether it's helping students embrace the fear of failure, working with entrepreneurs or roaming the halls of the world's best companies, Emma's message is clear - what got you where you are today, won't get you where you need to be tomorrow.

In 2012 Emma curated TEDxMongKok, one of the regions most celebrated TEDx events. She spoke at TEDxHKUST in 2013 and is a regular contributor to the TED Community. She was named one of Hong Kong's most inspiring young women last year and in 2008 made headlines in The Sunday Times having been named by Management Today as one of '35 Women Under 35' to watch.

Carol Kim, Managing Director, The Blackstone Group and 100 Women in Hedge Funds Co-Founder Carol Kim is a Managing Director in the Investor Relations & Business Development Group and is based in Hong Kong. Since joining Blackstone, Ms. Kim has been involved with investor relations and new business development in Asia. Before joining Blackstone in 2008, Ms. Kim was based in New York as a Vice President in the Absolute Return Strategies Group at Lehman Brothers, where she was responsible for client communications and reporting to its hedge fund and fund of hedge funds clients. Prior to joining Lehman, she was Director of Marketing at Continuity Capital, LLC and a Marketing Associate at P. Schoenfeld Asset Management. Ms. Kim began her career in investor relations at LG Electronics in Korea and Allied Canadian Development Corporation in Toronto. Ms. Kim received a BA in Urban and Economic Studies from the University of Toronto. She is a Co-Founder and Board member of 100 Women in Hedge Funds.
