Steve Bernstein is currently the Chief Executive Officer of SinoPac Solutions and Services based in Hong Kong. The company offers portfolio managers, both traditional and hedged, a comprehensive fund administration and support platform.

Previously, he was CEO of Oppenheimer Investments Asia, based in Hong Kong from December 2009 until December 2011. He's been involved in Asia since 1983 and spent five years in Japan during his 23-year career at Citigroup.

At Citigroup, Steve ran the Fixed Income business in Asia and upon returning to New York, worked on planning and strategy for the Corporate and Investment Bank, integrating acquisitions such as Schroeders PLC and overseeing disaster planning and business continuity in the wake of the September 11 attacks. In 2003, he was tapped to run Global Securities Services in the Corporate and Investment Bank. Steve retired from Citi in 2005.

Steve is also one of the industry advisors to Henley Business School's first Executive Hedge Fund Program here in Hong Kong.
