Whilst at Merrill Lynch, where he was responsible for the bank's Pensions Advisory Team, he transacted the industry's first LDI transaction in 2003. He is a regular commentator and blogger on issues concerning pensions and long term care and he is also the founder of PitchCamp which teaches young people the dark art of public speaking.
