Before joining CME Group, Morales spent several years at Goldman Sachs, last serving as head of the Asia arm of the Goldman Sachs Global Markets Institute based in Hong Kong. At Goldman Sachs, she also was an executive on the fixed income, currency and

Currently, Ro sits on the Board of the Yale Alumni Fund (YAF), elected to the Executive Committee for 2015-2016, and the Leadership Giving Committee. In addition, she sits on the Policy Committee of the Foreign Exchange Professional Association (FXPA), the RMB USA Working Group created by Michael Bloomberg - Operating Models subcommittee, is a core founding member of the Post Distributed Ledger (PTDL) and co-Lead of the Regulatory Working Group, FIX Protocol Digital Currency and Blockchain Working Group, and several other industry groups.

Ro holds a M.B.A. in Finance from London Business School and a double B.A. Degree in History and Studies in the Environment from Yale University. Her senior thesis was on the Proliferation of Chemical and Biological Weaponry in the 20th century.

Pat Gillman has spent most of her legal career in the alternative investment industry, first with the Commodity Futures Trading Commission, then in private practice followed by serving as US Counsel to a London-based hedge fund and now as an industry consultant. She has spoken widely on industry topics, including making multiple presentations to the China Securities Regulatory Commission, the Shanghai Futures Exchange, the Dalian Futures Exchange and the China Financial Futures Exchange on the operation of the US futures markets. She is also an experienced member of advisory committees to registered investment advisors and commodity pool operators.

Gillman is Treasurer of the Smith College Alumnae Association, an organization with 48,000 members, and serves on the Investment Committee to the college's endowment.
