Amanda Pullinger, Chief Executive Officer, 100 Women in Hedge Funds
Ms. Pullinger is the Chief Executive Officer of 100 Women in Hedge Funds. She leads a small staff team and manages over 350 volunteer practitioners globally, overseeing the operations of the organization, which now has over 13,000 members in 20 locations.

Ms. Pullinger is a former principal of Aquamarine Capital Management, where she was responsible, over a period of seven years, for managing marketing, investor relations and back office administration for two private investment funds.

Ms. Pullinger is currently Chairman of the Board of The HALO Trust (www.halotrust.org) and serves on the Advisory Board of the Oxford Alumni Association of NY. She previously served on the Boards of SkillForce, NYU Cancer Institute and Girls' Prep, and was on the founding Board of 100 Women in Hedge Funds, serving as its President for two years. She is a member of the British Academy of Film and Television Arts (BAFTA) and a Fellow of the Royal Society of Arts.

Ms. Pullinger graduated from Brasenose College, Oxford University in 1987 with an Honours Degree in Modern History. She earned an MBA from La Salle University, Philadelphia, in 1998, and received the Academic Award for MBA student of the year as well as the Beta Gamma Sigma designation.

Julia Raiskin, Managing Director, Head of Investor Sales and Relationship Management Asia Pacific, Citi
Julia Raiskin is Managing Director and Head of Investor Sales and Relationship Management for the Asia Pacific region at Citi. In this capacity, she is responsible for developing and executing Citi's investor client strategy across all products and geographies in the region as well as managing the Markets Relationship Management team. She heads a diverse, regional team of professionals with a strong focus on both flow and structured product transactions for both our institutional investor and retail client franchises, including partnering with the Citi Private Bank to manage the joint venture. Julia assumed this role in October 2015.

Julia is a member of the APAC Markets and Securities Services management team, and a Director of the (CIBSL) Citibank Investment Bank (Singapore) Limited and Citigroup Global Markets Singapore Pte Ltd. Before taking on her current position, she headed the G10 Rates Sales team for Asia Pacific since 2009. Julia has been responsible for the distribution of global fixed income products (including cash and derivatives) to Asian Institutional investors, including Central Banks, Sovereign Wealth Funds, Banks, Asset Managers, Insurance Companies and Leveraged Accounts.

Julia joined Citi in Singapore in 2007 to run Retail Structured Products Sales. In that role, she was responsible for the development and distribution of Citi's cash bonds, OTC derivatives, structured notes and funds to both internal (Citi Private Bank and the Global Consumer Group 'Citibank') and external clients throughout Asia. Prior to moving to Asia with Citi, she spent 8 years in London in a variety of sales and structuring roles. She ran European Corporate FX Sales for JP Morgan. She also worked in derivatives solutions at Morgan Stanley and FX structuring at Lehman Brothers, where she began her banking career.

Julia holds a doctorate in Law from Oxford University, where she was a Rhodes Scholar, and a Bachelor's Degree (with the highest honors) from Harvard University. She is currently on the Board of a Crisis Management Group - a Voluntary Welfare Organisation. Julia was born in Moscow, Russia and moved with her family to the US in 1990. She currently lives in Singapore with her husband and three children.
