For a brief period, Sheikha Hend was involved in managing multi-billion dollar projects in Qatar and the UAE. And although she has proven herself quite adept in this field, her passion was still in the arts and fashion-centric endeavours. She is also the Ambassador of the Breast Cancer Foundation. Although preoccupied with her various business and personal interests, Sheikha Hend has never lost her passion for painting, occasionally producing artworks and participating in art shows Qatar and Dubai. All the proceeds from her art are then used to support various charities in many parts of the world - a personal advocacy where she finds such deep affinity and fulfilment.

Sheikha Hend's latest project is a book, a collection of true stories from around the Arab community called "The Black Book of Arabia". The project has been realised with the partnership with Bloomsbury Publishing Foundation in Qatar and is currently proving to be a resounding success in the Gulf, EU and the US regions.
