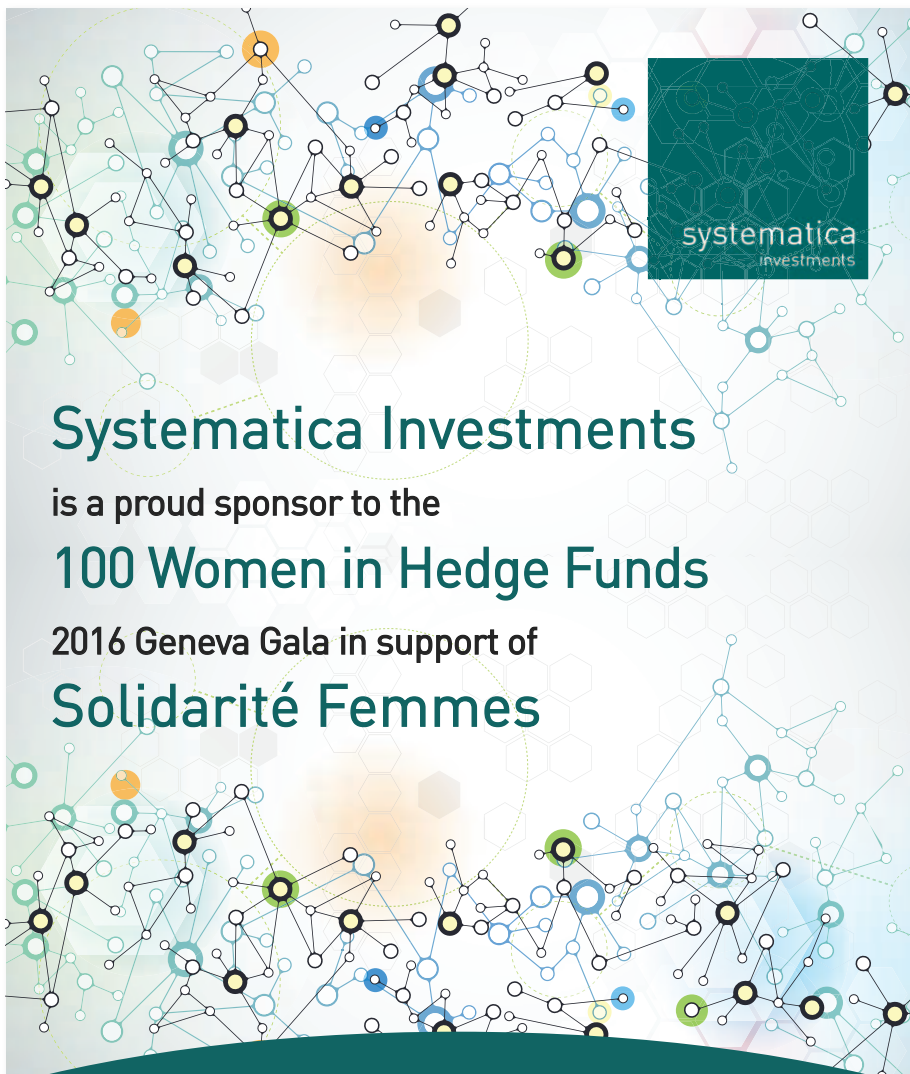

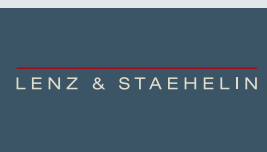

## Children are never spared

In Switzerland, 1 in 5 women is a victim of domestic abuse during their lifetime. Most of these women are mothers. Therefore, a large number of children suffer from the consequences of these occurrences. Children growing up in settings of domestic abuse are denied their right to a stable and secure home. These children need adults whom they can depend on and who can offer them a stable environment that allows them to develop harmoniously. Instead, their right to a stable household is regularly violated. There are many repercussions on these children: health wise (sleeping disorders, eating disorders, behavioral disorders, emotional disorders, and post-traumatic stress disorders) but also in regards to the child-parent relationship (attachment issues, parentification). Hence, it is essential to support mothers so that they can protect and support their children in the most adequate way possible.

## Solidarité Femmes and the children

Solidarité Femmes provides a psychosocial and therapeutic support to women victims of domestic abuse and to their children. The association is specialized in mother-child consultations. After more than 20 years of experience, Solidarité Femmes helps young mothers understand and respond to their children's needs by providing them access to the necessary help.

## Resilience

There are many factors (individual, familial, environmental) that can protect children's development and support their adaptation capacities. Hence, all children are not affected in the same way by domestic violence. According to the studies on the subject, between 31% and 65% of exposed children are considered as resilient. Many of the studies demonstrate that the mother-child relationship becomes a determining factor for the child's protection. Solidarité Femmes has chosen to work on this relationship in order to have the maximal impact on the children's resilience.

## Prevention and support program

Thanks to the funds that will be collected through this gala, 600 children who currently experience domestic violence will be supported in a sensitive and sustainable way in order to break the cycle of violence in their families. Thank you for helping these children in becoming well balanced and responsible adults.

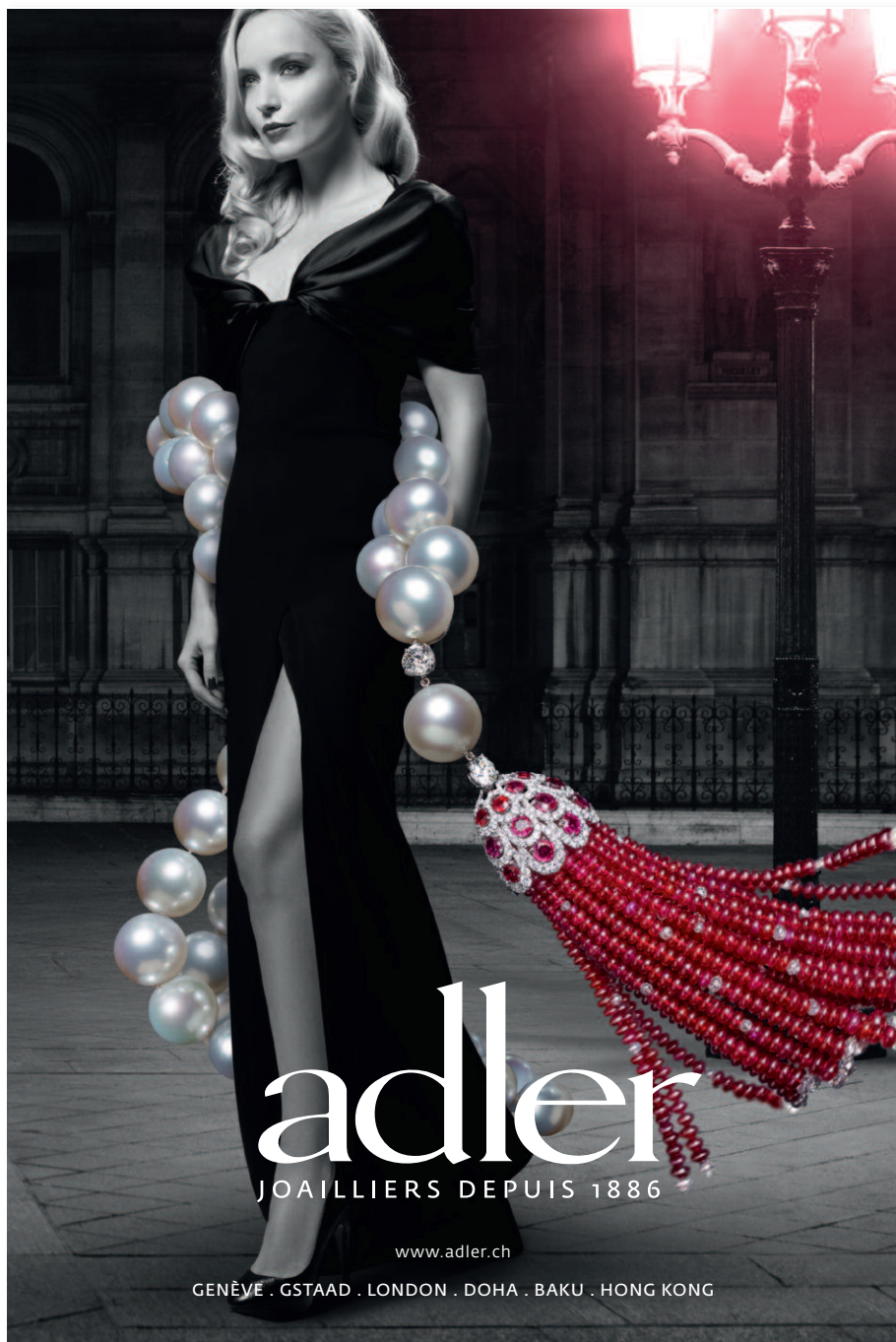

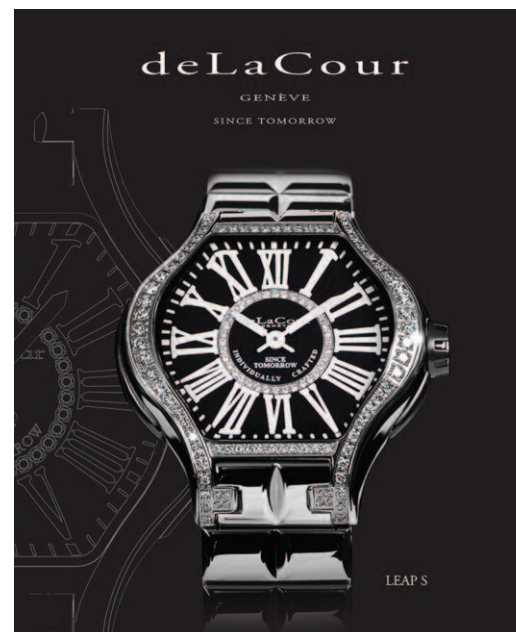

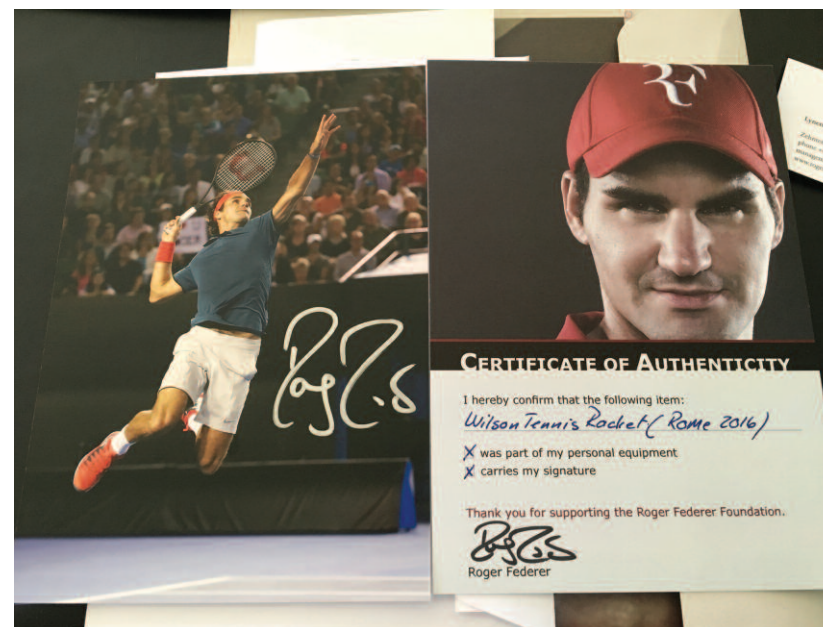

Music is anything but a job to Yael Naim and David Donatien. It is entwined in every aspect of life for these musical and romantic partners, who recorded their third album together in their family home on the outskirts of Paris.

## Carmen Perrin

Born in La Paz, Bolivia.

In 1960 when Carmen was only seven her family went into exile in Switzerland, the native country of her grandfather. Carmen completed her education and artistic studies in the city of Calvin. In 1981, she earned her diploma from "Ecole des Beaux Arts" (HEAD) in Geneva and began teaching at the institution in 1986. During the same year, she participated in an exhibition at the Musée Cantini in Marseille where she lived and worked for the next eight years.

In 1993 she earned a scholarship from the "Landis and Gyr Foundation", which enabled her to live and work in London for two years.

Carmen is currently based in Geneva and travels regularly to France where she has a second workshop.

Since the 80s, Carmen has imposed herself as a plastic artist who realises sculptures. She began working closely within the architectural and landscape contexts in the 90s. Carmen seeks to create works that articulate the relationship between light, materials, architectural and social qualities of public space. In Geneva, among other permanent exhibitions, she was commissioned to create the large doors for the History Hall of the Cornavin train station. These doors play with voids and solids in various angles and bends through the use of concrete and glass.

In 2005, she retired from teaching to devote herself entirely to her artistic research. In 2011, she earned a second scholarship from the "Landis and Gyr Foundation" which enabled her to move to Berlin for 6 months. Carmen was granted the Cultural Prize from the "Leenaards Foundation" in 2015.

Currently, she works on projects related to the public space and carries out research which closely articulates the practice of sculpture and drawing.

Carmen Perrin has received numerous awards for her achievements. Her artwork is displayed in museums, galleries and art exhibitions.

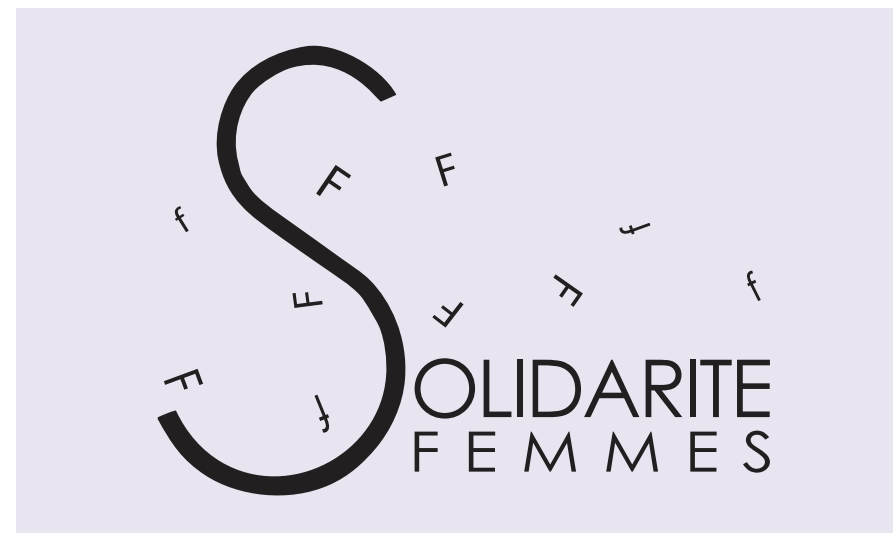
